FPOA GAZETTE HISTORICAL ARTICLE 8 By George W. Taylor

Continuing through 1981 The Farm had its own cable television company. Over by the Farm Mutual Water Company (FMWC) on the hill just below where the water tank is, there was a small building with a large parabolic dish antenna. It was announced that there would be 200 programs per month, that movies would be shown two-tosix times each month, that a converter box for Channel 3 would be required. If you wanted the service it would cost twenty-five dollars to install and there would be a monthly fee of \$11.00, and further that the service was planned to begin by June 1, 1981.

The three volunteers alluded to last time that Raye Knowlton recruited to help update the CC&Rs were Cathy De La Cruise, Lorna Pohlman and Beverely Keys. At that time also, 75% of the electorate of each phase of this development had to approve any changes, that was almost impossible, and as it would turn out, it was impossible. Bottom line was - No changes were able to be made.

Another project at that time was the air conditioning in The Farm Barn would be a reality by May of 1981, but window air conditioners, unless hidden from view, was against the rules.

The FMWC was concerned about residents installing water softeners because there was some problem with the salts getting to the waste system or something like that, so the FMWC Board of Directors put out a notice that told of the problem and asked residents not to install such a device.

I realize that some of this stuff doesn't have any apparent relationship to most all of the newer folks here, but bear with me, it's part of the course of events that made this place what it is where you live,

Anyway, came January 1982, that was a year that saw many changes and events. Mr. John Tomlinson, became one of our Farm Presidents succeeding Raye Knowlton, the first resident president. One of his accomplishments favored all of us by his certification of an amendment to Article (9) of the Articles of Incorporation, wherein we all get a share of any proceeds relating to the dissolution of The Farm after all the bills are paid, if ever it should happen.

A second certifier here was the FPOA Secretary of the time, Mrs. Shirley Chilibolost. Remember, she took over the Farm News Letter and re-named it the Farm Gazette. She is also the wife of Bill Chilibolost who succeeded John Tomlinson, as the third resident president.

It is interesting to note that the majority of these earlier folks never completed their term of office that they signed up for and resignations were the order of the day.

As alluded to in my last article, the Amphitheater over in Phase Six was dedicated on the April 16, 1982. There is a sign posted to this event along Citrus Hill Road. Further, I discussed the road access and vandalism problems at RV-2 last time but didn't mention that the developer also planned and developed a campground and picnic area along west side of the RV-2 under the oak trees there. Long since abandoned.

Because of the vandalism that I had mentioned before, the site was changed to use the area to grow community gardens. There is a sign along The Farm Road that directs a user into the area. So now, again the Association was running out of RV parking and thus came RV-3 on common lot 122 over below where the water company does business.

Going back to the Farm Barn and the two shuffleboard lanes downstairs and a meeting room upstairs, besides running out of spaces for RVs to park, so were they running out of space for people to sit. To rectify this problem, the board moved the meeting room from upstairs to downstairs and took over the shuffleboard lane space. Today, it is still our meeting room and the upstairs space is now offices, a conference room and a kitchen.

There were still cries for the second and larger promised clubhouse but the developer gave no guarantees. There were three clubhouses advertized and the cries continued until January 5, 2013 when we had the grand opening of Millers' Mill. The clubhouses that were planned beyond The Farm Barn were never built as the land went back to the bank in later years. It is worth mentioning that the entire South end of The Farm beyond where The Farm Road ends was planned to be 5-acre parcels with a large equestrian center to be built as the third club house.

All this land went back to the bank. The area has been bought and sold two additional times of which the most recent was bought for the third time but not developed to date. There was "Sunset Ridge", "Spring Valley" and the latest is "Wildomar Meadows". To continue, a significant yearly event in those years was "The Farm Faire" usually held in the fall of the year and put on by a lady by the name of Jackie Dyck.

There was also a fellow that lived in the house recently sold by David and Earlene Cole. His name was Ernie Rymer. Earnie was great and always the Master of Ceremonies at the Farm Faire. He was also a prominent figure in The Farm Lions Club of past years in this community along with Tim Mendoza and Doug Harms.

The Farm Lions Club was the instrumental organization that was responsible for the construction of Harrow Hill Park, located at the West end of the street. A lovely place where there is a water wheel, two small ponds surrounded by picnic tables and a waterfall that trickles into one of them.

In May of 1983, we found ourselves caught up with Phase 8 and with the population still growing. A voting quorum at that time was 50% +1 to equal 391. Dale Odekirk, one of the developer brothers still remained on the Board of Directors.

I was so sick that I had to stay in the hospital for six days and nights. I was so sad! Since Parvo is so contagious, My Mom and Dad couldn't even come to visit me. Finally, I got better and was able to go home. I was still very weak but SO happy! (Note: the vaccine manufacturer, Merck, reimbursed us \$5,000 of the vet bills since their vaccine didn't work.)

My Mom took me to puppy training and I learned all the things that helped to make me the good dog that I am today. Zoey and I love to run, chase sticks and play tug-ofwar. My favorite game is "Search" where my Mom hides treats in open boxes on the floor and we have to "search" for them using our noses. But our very favorite thing is going to the Dog Park here at the Farm every day! I have a really great life, surrounded by my peeps and Zoey who love me so much! I'm always loving on them to show them know how grateful I am that they found me.

Remember: Saving one dog will not change the world...but for that one dog, the world is forever changed!

 If you have a medical appointment, call the healthcare provider ahead of time and tell them that you have or may have COVID-19.




5. For medical emergencies, call 911 and **notify the dispatch personnel** that you have or may have COVID-19.

- **6.** Cover your cough and sneezes with a tissue or use the inside of your elbow.
- 7. Wash your hands often with soap and water for at least 20 seconds or clean your hands with an alcohol-based hand sanitizer that contains at least 60% alcohol.
- 8. As much as possible, stay in a specific room and away from other people in your home. Also, you should use a separate bathroom, if available. If you need to be around other people in or outside of the home, wear a mask.
- Avoid sharing personal items with other people in your household, like dishes, towels, and bedding.
- **10.** Clean all surfaces that are touched often, like counters, tabletops, and doorknobs. Use household cleaning sprays or wipes according to the label instructions.

Any architectural changes or improvements to the exterior of your property require approval from the ACC before work can be initiated. You must fill out an Architectural Change Application; this application can be picked up at The Farm office or on the website at www.thefarmpoa.org. All architectural change applications must be submitted to The Farm Office <u>before the last Friday of the month</u>. **ACC meetings are currently held the first Wednesday of every month**.

Responding to Violation Letters - Tips:



Tip 1: Understand why the rules exist

The Architectural Control Committee is in place to ensure that every homeowner's equity is protected. Not everyone has the same ideas about how a community should look or what type of conduct qualifies as "neighborly." By organizing these guidelines and formalizing them in our governing documents, The FPOA clearly outlines what will be expected from you and what you have the right to expect from your neighbors.

Tip 2: Ask why you received the notice

If you're caught off guard by a notice, then there's a chance you didn't know you were in violation of ACC rules. Contact the Architectural Control Administrator at The Farm office and ask for an explanation. Understanding where the ACC is coming from can help you contextualize the notice.

Tip 4: Understand that it is a progressive process

Just because you receive a violation notice doesn't mean you are automatically subject to a fine. The process looks like this: 2-week courtesy notice, notice of hearing with the FPOA Board (10-days to correct violation), and lastly a notice regarding the decision to fine for non-compliance. From the first notice to the last, the FPOA gives residents over 25 days to correct their violation; you will have ample time to ask questions, correct the problem and share your concerns with the board before facing a penalty.

Tip 5: The process is confidential and is not an attack on your character

Please do not assume that you are the only one on your street who received a violation letter. After every inspection, we receive complaints asking why a violation letter was sent to the person and not the "messy neighbors next door". Please know that the process is confidential, you will not receive status updates on your neighbor's compliance notices. Trust that the ACC is committed to impartiality; please know that due process is underway.

Tip 6: Familiarize yourself with FPOA Architectural Guidelines

Know what is contained in the Architectural Guidelines so you are aware of which compliance issues need to be absolved. Read the requirements, how they were violated, the fine schedule, and the remediation process. Understanding the contents of The Farm rules and regulations makes it easier for the discussion to move

forward.

The Farm Safety Page

Safety Awareness Month

February is Safety Awareness month, so we're sharing our favorite safety and security tips. What does safety actually mean? Safety is both being physically safe from harm and also the act of avoiding situations with recognized hazards to keep yourself safe. Practicing good safety starts at home, so always be sure to be aware of potential hazards in your daily life.

1. Be careful when walking to your car at night. Stay in lit areas, walk with others, and always be aware of your surroundings. Most cell phones have a flashlight so use it.

2. Utilize your phone as a safety tool; make sure you have all your emergency contact info programmed into your phone, so it is quick and easy to access.

3. Be cautious and trust your gut when dealing with people through online services. When necessary, agree to meet in public places, and only exchange goods, services, or money in person. When you pay for a service or product, use a credit card, NOT a debit card. If something goes wrong, you can deny payment with your credit card company and they will file a dispute for you. If you pay with a debit card, the monies are taken out from your bank account immediately. Never pay for services in full up front.

4. Check your fire and carbon monoxide detectors regularly to make sure they are working and be sure to replace the batteries as needed.

5. Make sure light bulbs are the correct wattage for the lamp you are using. Incorrect wattage is the number one reason for electrical fires!

6. Create an emergency kit for your car in case you break down and have to wait awhile for help to arrive. Water, snacks, a first aid kit, and flares are a great start. Check with The Farm CERT team for emergency kits for your home in the event of an emergency.

7. Periodically revisit emergency contact lists and meeting areas with your child to make sure they know what to do in case of emergencies.

8. If you are going hiking, make a trip plan for your family members saying where you're going and when you expect to be back. If you are not home when you're expected, they'll have some information on where to look for you.

9. Never leave cooking food unattended; fires can start quickly, particularly if grease is involved! Being present physically and mentally while cooking will ensure you are able to react quickly if something does catch on fire.

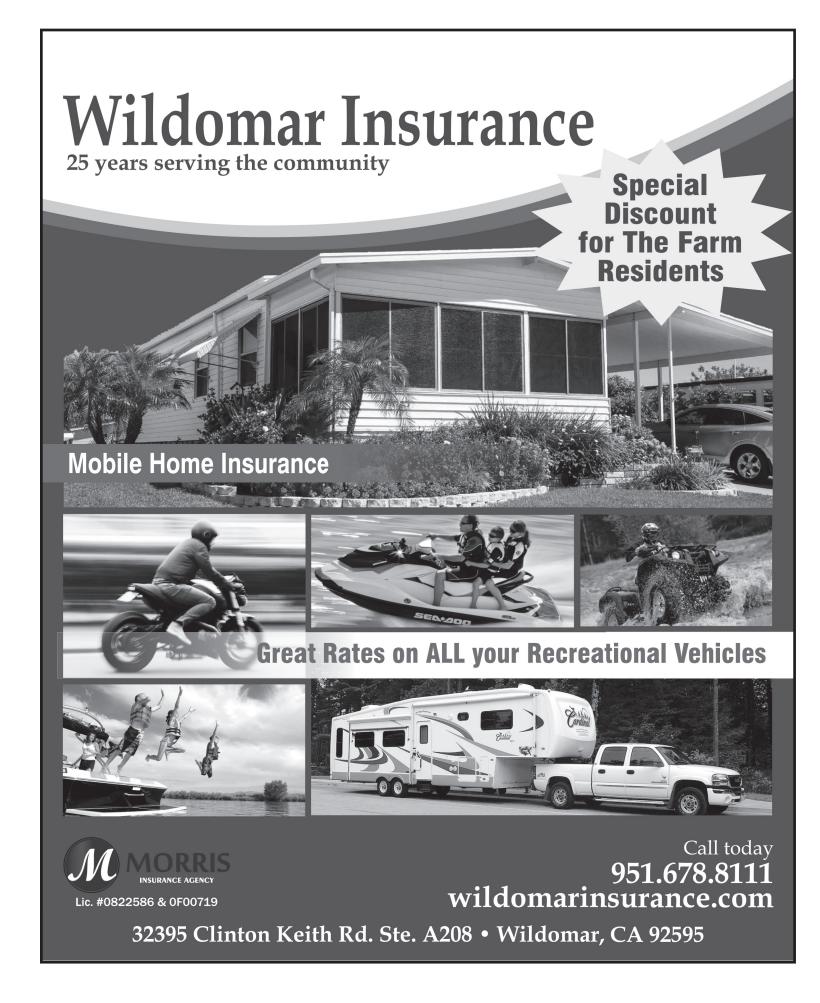



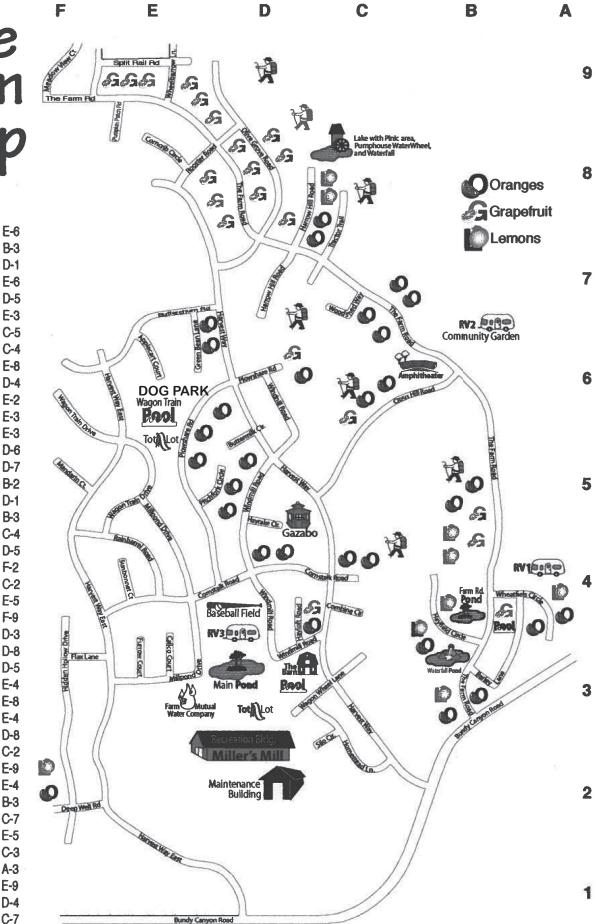
