Matt Sievert-Director


Matt stated he had no tasks yet to report on. He reminded the Board he is here when needed.



ODD, BUT EFFECTIVE HEALTH HACKS

Always check with your primary physician before making any changes to your diet or trying any natural remedies.

Chocolate for a cough. Here's a good excuse to indulge a bit. Studies show that an alkaloid compound in cocoa called theobromine quiets the nerves that cause the tickle in your throat better than most over-the-counter cough syrups. Experts suggest sucking on a square of dark chocolate for the best results.

Olive Oil for sunburn. Olive Oil has antioxidants that can help repair the skin damage caused by sunburn. It is also an excellent moisturizer. Soak a cloth with olive oil and put it in the refrigerator until chilled, then apply it to the sunburned areas.

Duct tape for warts. What can't you do with duct tape? Research suggests it's a better fix for warts than cryotherapy. Cover the wart with a small piece of duct tape and leave it on for three to six days. Remove the tape and abrade the wart with an emery board. After 12 hours of airing out, put a new piece of duct tape on the wart and repeat the procedure until the wart is gone.

Iced milk compress for rashes. Milk soothes inflamed skin by creating a protein film. Mix milk in a bowl with ice. Soak a cloth and wring it out. Apply the milk compress for 15 minutes and repeat as necessary.

Krazy Glue for cracked heels. "No amount of cream of moisturizer will bring that crack back together," says Jhin. "Krazy Glue is a great little trick to fix it." Soak your feet in water for a few minutes, then apply moisturizer and dab the glue on cracks. One application should be the trick.

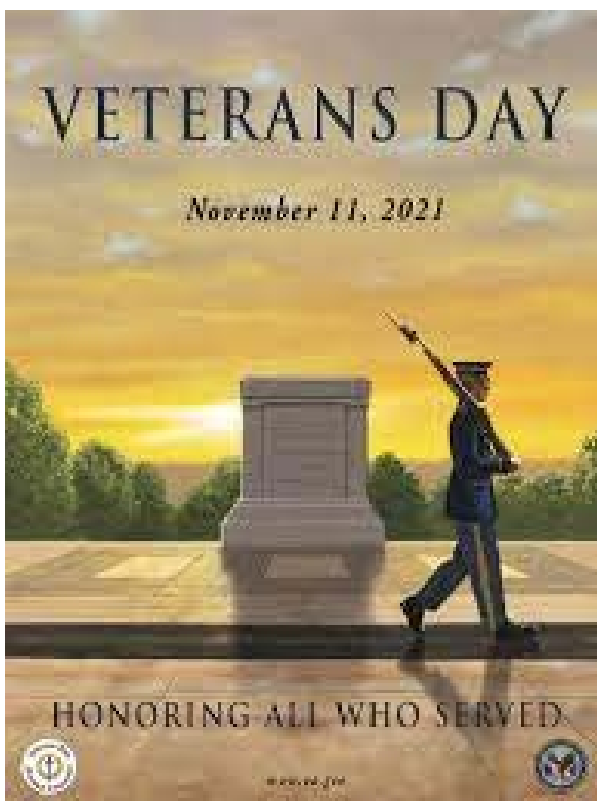
On December 4th there will be a Christmas Light Parade...complete with Santa Claus! (More information to come.)

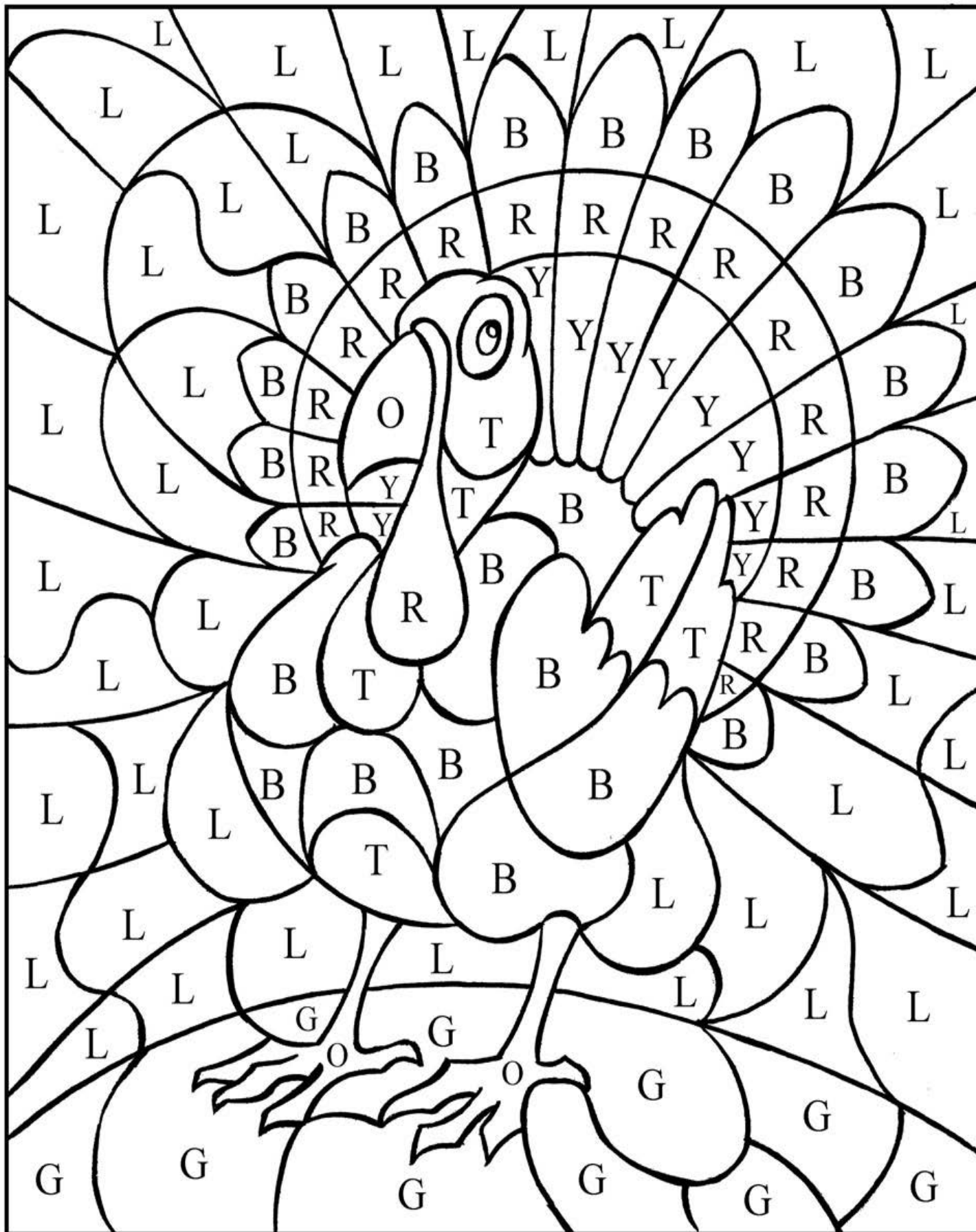
On December 11th we will be having a quarterly Blood Drive with a free BBQ for those who donate. A small donation will be requested for those who can't donate but would like some lunch.

"YUMMY FOR THE TUMMY"

APPLE-WALNUT CROSTATA

Submitted by Jane Merrow

6/7 Jonagold apples, peeled, cored and sliced thin

½ cup packed light brown sugar

½ cup chopped walnuts

1/3 cup flour

Dash of Vanilla extract

1. Preheat oven to 350 degrees. Coat a baking sheet and set aside.

2. Mix all ingredients together in a large bowl and toss well.

3. Place piecrust on baking sheet

4. Spoon apple mixture into center of piecrust and fold up edges of pastry to capture apples and juices, leaving apples exposed in center. Dot with butter.

5. Bake 45/50 minutes, or until crust is golden brown. Makes 8 servings

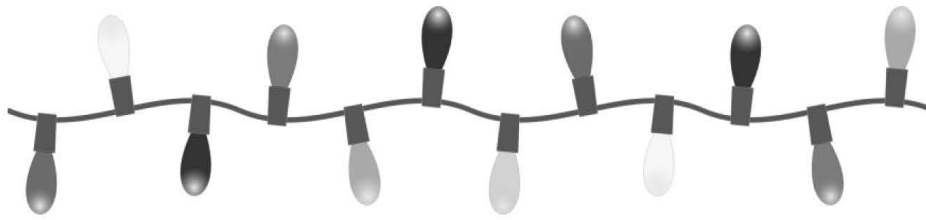

FPOA HISTORICAL ARTICLE # 17
FOR THE NOVEMBER 2021 GAZETTE

To continue into late 1986, remember that the Developer promised three Clubhouses, the first constructed as a two-lane Shuffleboard Court downstairs and a Meeting Room upstairs. You know it as The Farm Barn completed in 1980. And as some of you do and some of you don't know, as The Farm developed, the population continued to expand and folks in 1986 continued to want a bigger and better Club House, and that only, this one was built.

This article came to mind as a reminder for those older folks, and for the younger generation that have no clue about the beginnings of what we know about a bigger and better Clubhouse that would become Millers' Mill.

The days of Dorothy Childs and Tina Miller and their attempts to raise funds to build a bigger and better one are long gone. By 1990, we found the Quimby Act, State law 66467 that required a Developer to contribute funds or dedicate land or both for active recreation in a new housing development. When the idea of Phase 10 came up, the then FPOA Board was convinced to appeal the Phase 10 Development plans designed to construct 200+ conventional type homes with no active Recreation at all.

Just after the turn of the Century, The FPOA Board appealed, and the "then-Supervisor" for our District was able to get for us, and we received \$340,000.00 as Quimby Fees.

Each of the then, three Developers were ready to begin the project, first advertised as a "Harvest at The Farm" and then as Cheyenne Valley, and the third was Artisan.

Between the three Companies getting involved with Phase 10, each contributed a third of the fees. [Thirty lots remained until recently developed.]

The FPOA Residents voted to Annex the Phase 10 Development into The Farm as one more Phase to Tract 6378, our Phase 1. [Know that all of the Phases in The Farm are annexed to our First Phase of The Farm Development]. We amended our CC&Rs to include Stick-built homes in Phase 10 into a Mobile Home Community and stated that only Mobile Homes would be permitted in Phases 1 through Phase 8-B.

I was asked by the FPOA Board of Directors around that time If I would take the project on, so, as the majority of you don't know, I was the Project Manager that built our FPOA Maintenance Shop building, and the building we all love to meet in called Millers' Mill. As such, I would come to rely on most of the Quimby Funds to get us off the ground to construct the building. So around 2011 I was well underway researching what it would take to build this new facility.

The first step in this effort was to determine the size and what type of building we should build. We decided that our best choice, considering the cost of labor and the ability for our Maintenance Department to help construct would be to build a metal building.

To this end, I went out to bid for companies that supported this type of product.

We selected a Company in Texas known as "Icon Building Systems and their subsidiary known as "Metal Building Depot". This structure came with a set of Pre Engineered Building Plans as a package, and they would erect it. The scope of these Plans was to provide only the ends, sides, and the roof. All of the interior work such as for Walls,

Electrical, & Plumbing, etc., to include a Grading Plan had to be designed and produced by a Professional Architectural Company we chose in Irvine California doing business as "OCAC" an Architectural Collaborative.

Now came the stretched-out hand of the City. I found an abundance of Fees that were required by the City. I tried to get us exempted because we were a Non-Profit Association in a Private Community and there would be no more impact than there already was with everyday traffic, but I was only partly successful.

These fees included the School Fee, a Bridge and Road Fee. There was Developers Impact Fees (known as DIF Fees). There was a General Construction Refundable Deposit Fee for the particular type of facility and who would own it. There was the cost of the Architect that had to produce the plans for the building interior Construction, Electrical, Plumbing, Air and Heat, Landscape, and Grading.

In addition, we were required to hire an Engineering Company to perform a Geotechnical Study of the ground that the foundation would be built on.

There was a requirement by the Edison Company. They required an Electrical Load Calculation so that the transformer they would install would provide a proper return on investment.

Our kitchen was to be classified as a Serving Kitchen that meant no stove and no cooking. Had we not satisfied desire we would have been required to install a sprinkler system in the building.

There was a Fire Department Fee with a requirement for a set of Building Plans.

After all of these requirements were satisfied, we hired an Excavator to dig out our 20 foot deep by 75 foot long and 45-foot wide foundation footprint.

The size and depth of the hole was based on the Geotechnical Study. After this hole was dug out, we were required to fill it back up a couple of feet at a time and compact the dirt fill each time until we were back at our grade level.

To ease your mind, this was to be a building for public use, not residential use, so when I was doing work that is not private use, different construction rulers apply.

By January 2012, we were ready to begin construction and our Maintenance Staff was working to build the 45 ft by 75 ft foundation, to include the required footers. Now, we were ready to hire a contractor to fill the foundation with concrete.

The content of this article and the next will bring this effort we made to your mind, and what it took to offer you a Saturday evening dinner party each month. I miss the camaraderie we had after we opened the building to The Farm Residents, and look forward to our get-togethers in the future.

The above dissertation helps set the stage related to our continuing efforts to build this bigger and better Clubhouse we reverently named " Millers' Mill.

My Historical Article 12, just before we opened Millers Mill in 2013 was devoted to all of the final chores that we had finished, and had to still be finished before we could call for our Fire and Final Inspection. Hard to believe the time has passed so quickly since then.

If you will indulge me again next month, I will give you a second look back to see what was required to open a "Public of The Farm" Building. I will be writing next months' article as I wrote it in the first person, in 2012, so bear with me when I give you that part of the perspective of the job. Until then, Stay Tuned.
